Bij het huren van een auto of camper sluit je een huurcontract af met de verhuurmaatschappij. Dit contract is onderdeel van onze reisovereenkomst. Dat betekent dat u ook aan de voorwaarden van de verhuurder gebonden bent. Het is belangrijk deze door te nemen. Bij het ophalen van de auto of camper dien je deze immers te ondertekenen in het huurcontract. Zo zijn er altijd uitzonderingen op de dekking van de verzekering, gebeurtenissen die niet vallen onder het afgesproken eigen risico, restricties aan de route of wegen die mogen worden bereden, kosten in geval van boetes, etc.

Een paar belangrijke voorwaarden en instructies.

Verzekering van de camper

Heb je gekozen voor de 'Max Cover' verzekering, dan is het eigen risico maximaal verlaagd, namelijk tot A\$ 1000, en is schade aan ruiten en banden gedekt, beide tot A\$ 500 per huurperiode.

Maar let op: er zijn altijd uitzonderingen die niet gedekt zijn. Zo is bij Crikey de schade aan de onderkant en bovenkant van het voertuig niet gedekt als deze niet is veroorzaakt door een botsing of 'roll-over'. Zie voor de uitzonderingen de uitgebreide huurvoorwaarden van Crikey hieronder.

Leeftijd bestuurder / passagiers

Crikey Camper Hire, minimum leeftijd 25 jaar

Red Dirt 4WD Rentals, minimum leeftijd 25 jaar

Let op: kinderzitje / 'boosterseat' is tot 8 jaar verplicht

Rijbewijs

- Je dient **tenminste 2 jaar** in het bezit te zijn van je rijbewijs.

- **Internationaal rijbewijs aan te raden:** De Australische verhuurbedrijven accepteren het huidige model Nederlandse rijbewijs (formaat bankpas). Uitzondering, In The Northern Territory (Darwin, Alice Springs, Ayers Rock) is een Internationaal rijbewijs verplicht. De Australische overheid is hier echter minder duidelijk over. Deze eisen een vertaling in de Engelse taal. Nu staat er niet veel, maar wel enige Nederlandse tekst op het rijbewijs. Om mogelijke verwarring en boetes met lokale overheidsinstanties, bijvoorbeeld de politie, te voorkomen raden we aan een internationaal rijbewijs van de ANWB aan te schaffen. Deze kost ongeveer € 19,- en is 1 jaar geldig (neem pasfoto en het geldige rijbewijs mee).

Walkabout is niet aansprakelijk voor eventuele boetes als de klant zonder Internationaal rijbewijs reist.

Transfers van en naar het depot

Deze zijn niet inbegrepen. Je kunt het beste een taxi nemen vanaf de luchthaven of je hotel. Bij het inleveren van de camper/auto zal de verhuurder een taxi voor je bellen indien gewenst.

Routebeperkingen 4WD's:

Het rijden op onverharde wegen is toegestaan, mits deze op de wegenkaarten zijn aangegeven, met in achtneming van eventuele afsluitingen en waarschuwingsborden.

NIET toegestaan zijn: Canning Stock-route, Old Telegraph Road (Cape York), Fraser Island, Simpson Desert, Gunbarrel Highway en Old Gunbarrel Highway, alle stranden lager dan de hoogwater markering en het rijden op de wegen die niet op de wegenkaarten zijn aangegeven.

Vooraf toestemming verplicht: Jim Jim Falls and Twin Falls including Jim Jim Road (Kakadu NP), Arnhemland and Central Arnhem Road, Tanami Road, Kalumburu Road (Kimberley, Mitchell Falls). De toestemming krijg je bij het ophalen van de auto na controle van de toestand van deze wegen.

Niet toegestaan is: rijden tijdens de nacht i.v.m. groter risico aanrijding met dieren.

GPS Navigatie:

Deze is bij de Crikey campers en Red Dirt 4WD's inbegrepen.

GPS tracking systeem:

Voor je veiligheid zijn de voertuigen uitgerust met een GPS locatie systeem, waardoor je persoonlijke route, locatie, snelheid en afgelegde aantal kilometers kan worden geregistreerd.

Boetes, administratiekosten:

Nagekomen boetes voor verkeersovertredingen dienen te worden betaald per creditcard. De boetes worden door Crikey verhoogd met administratiekosten.

Problemen, pech of vragen onderweg

Crikey heeft een 24-uurs 'Roadside Assistance' telefoonnummer.

Neem altijd direct contact op met Crikey als je pech hebt, schade, noodzakelijke reparaties of klachten onderweg, dan kunnen ze je zo goed mogelijk helpen.

HIRE RATES

rates for the period 1st April 2025 – 31st March 2026

TAX

Our rates include the Australian Goods and Services Tax (GST)

DATE CHANGES

An agent can change dates where the total amount of days remains the same and no change fee applies. Changes are subject to availability.

An agent can change dates where the total amount of days increases, and no change fee applies. Changes are subject to availability.

An agent can change dates where the total amount of days decreases, and no change fee applies however the Cancellation Conditions apply as outlined in the terms and conditions of hire. Changes are subject to availability.

PICK-UP & DROP-OFF LOCATIONS

All rental events must be picked up from a nominated depot location (Perth, Broome and Darwin).

Should a rental conclude at a location other than a nominated depot location then an additional "Transport fee" will be charged equal to the cost of relocating the assets to the closest nominated depot. Rental fees and applicable LRO still apply during transit and conclude upon delivery to a nominated rental location. Prices available upon application.

PICK-UP & DROP-OFF LOCATIONS CHANGES

An agent can change the pick up and drop off location up until 90 days pre-rental and no change fee applies. Changes are subject to availability.

Changes less than 90 days would be considered a cancellation/ rebooking and may attract a cost to the hirer as per the Cancellation conditions. Changes are subject to availability.



LIABILITY REDUCTION OPTIONS (LRO)

Our Liability Reduction Option (LRO) rates are set out in point 5 of the Schedule.1 and 2. Liability Reduction Options can be selected and/ or changed up until the day of pick up.

SECURITY BONDS

Our Security Bonds are set out in point 5 of the Schedule 1 and 2 and are held in trust until the conclusion of rental. The conditions of return are outlined in our terms and conditions.

- Nil Credit Card Fees are applied to Security bond payments.
- Funds can only be returned to the same card upon which the original bond was charged.
- The company is not liable for any financial institution charges, interest or exchange rate variances.

LONG TERM DISCOUNT

Long Terms discounts are applied to the daily hire rate and are applied to the total hire duration. Long Term discounts are not applicable to LRO rates. Our discounts for long term hires are set out in point 6 of the Schedule 1 and 2.

REMOTE LOCATIONS FEES

Crikey Camper Hire does not charge remote location fees.

ONE WAY FEES

Crikey Camper Hire does not charge one-way fees, except where our equipment is returned to a depot or location not designated as a "Depot" in this document where a "transport fee" would apply.

SATELLITE NAVIGATION SYSTEMS (GPS)

Crikey Camper Hire and Red Dirt 4WD Rentals offers Satellite Navigation Systems (GPS) with all hires at no extra charge.

SATELLITE PHONES

Crikey Camper Hire and Red Dirt Rental offers Satellite phone hire via a 3rd party.

No less than 60 days notice of this requirement is required and the order must be included on the agent booking. The additional cost is outlined in point 7 of the Schedule 1 and 2.

LINEN

Linen is provided per person at no additional cost for hires exceeding 15 days.

For hires between 7 and 14 days the cost is outlined in point 7 of the Schedule 1 and 2.



CHILD SEATS

Baby/Toddler seats compliant with Australian safety standards can be supplied upon request. The fitting of the baby seats is the responsibility of the customer. A maximum of 3 (three) Baby/ Toddler seats can be fitted to the vehicle. Baby/Toddler seats are included with all hires at no extra charge for hires of 15 days or more. For hires between 7 and 14 days the cost is outlined in point 7 of the Schedule 1 and 2.

OUT OF HOURS FEES

- Out of hours' delivery or pick up and Out of season depot opening facilities are offered and are subject to availability.
- Out of hours drop off or pick up needs to be arranged no later than 60 days pre-hire.
- Out of season depot opening facilities needs to be arranged at the time of booking.
- Out of hours' fees and out of season depot opening fees are outlined in point of the 8 of Schedule 1 and 2. Standard hire terms and conditions apply.

CREDIT CARD FEES

Credit Card fees of 1.8% apply to Hire Fees and LRO payments by Point of Purchase transactions by the hirer.

Credit Card fees are waived on Security Bond payments.

Cash, Debit Cards and American Express are not an accepted method of payment.

Security Bond claims and administration fees are subject to a 1.8% credit card fee.

EXCHANGE RATES, FEES AND INTEREST

All hire transactions are carried out in Australian Dollars (AUD). Crikey Camper Hire is not liable for any currency fluctuations, fees or interest under any circumstances.



Key Terms & Conditions

HIRE TERMS

All hires are to be enacted using hire documents supplied by Crikey Campers WA Pty Ltd and subject to:

The hirer providing:

- Personal details required for the rental agreement
- A valid drivers licence in the name of at least one person included in the rental agreement and for each nominated driver. If the license does not include English translation then an International licence will need to be presented in conjunction with their standard licence
- A Credit Card in the name of at least one person included in the rental agreement to act as security over the hire. Cash or Debit Cards are not an acceptable form of security
- Personal contact details necessary for us to meet legal compliance and carry out the functions and activities of our business should they not be included in the rental agreement

The hirer acknowledging:

- The rental agreement
- The maximum liability applicable for the hire event
- The equipment condition report
- The cleaning agreement

Payment of:

- The hire fee, including any LRO payment, prior to the commencement of hire
- A security bond equal to that of the Standard Risk Taker Liability should an LRO not be selected

INSURANCE AND AGE LIMITS

Hirers must be between 25 and 75 years of age to hire from Crikey Campers and Red Dirt 4WD Rentals and hold a valid Unrestricted Drivers Licence as issued in their country of origin.

Each nominated driver of the vehicle needs to be advised and recorded on the rental agreement pre-hire. Drivers not recorded on the rental agreement are not permitted to drive the vehicle.

Hirers under 25 years of ages are not permitted to drive a Crikey Camper Hire vehicle.

Hirers under 21 years of ages are not permitted to drive a Red Dirt 4WD Rental vehicle.

All vehicles are comprehensively insured. The Hirer's liability per event is limited to the Standard Cover Liability amount or as reduced by any Liability Reduction Option (LRO) accepted by the Hirer prior to the commencement of the Hire Period. Full details on Liability Reduction Option (LRO) rates are set out in point 5 of the Schedule.



LIABILITY REDUCTION

The hirers liability is applicable to each individual Claim event or incident giving rise to a claim including where liability is reduced by any Liability Reduction Option (LRO) accepted by the Hirer prior to the commencement of the Hire Period. Full details on Liability Reduction Option (LRO) rates are set out in point 5 of the Schedule.

FULL RESPONSIBILITY

Whilst the hirer can reduce their liability in the case of an accident by purchasing an LRO, the hirer is fully responsible for:

- Any under-body damage,
- water ingress, and
- Maximum \$8,000 liability for roof damage plus Consequential Loss
- In the event of any breach of the terms and conditions a hirer's liability is unlimited in relation to Property Damage, Consequential Loss or Third-Party Damage.

Should damage occur during the rental period the hirer is required to report the damage within 24 hours by phone or email. Should a hirer fail to report damage then this may result in a claim for demonstratable consequential losses.

Should a fault occur with the equipment during the rental period the hirer is required to report the fault within 24 hours by phone or email. In accordance with Australian Consumer Law, the company will take all reasonable efforts to rectify the fault. Should a hirer fail to report the fault then this may effect a hirers claim under Australian Consumer Law.

DRIVING RESTRICTION

4WD and/or off-road safari campers are not permitted on the following areas:

- Canning Stock Route
- Fraser Island
- Simpson Desert
- Old Telegraph Track, Cape York
- Gunbarrel Highway and Old Gunbarrel Highway
- Any beach, below the high tide mark
- Unformed tracks

4WD and/or off-road safari campers are permitted to travel to the following areas only with the express permission of Crikey Campers as recorded in "Special Conditions" of the rental agreement pre-hire:

- Jim Jim Falls and Twin Falls including Jim Jim Road
- Arnhem Land including Mainoru and Central Arnhem Road
- Tanami Road
- Kalumburu Road



From time to time should an area be deemed to present undue risk to the client or equipment the company will inform the client pre-hire of any additional restricted areas not currently outlined on the driving restriction list. Crikey Campers liability does not extend to any 3rd party arrangements

Vehicles, campers and caravans are not to be used contrary to any road sign or other similar warning sign or direction by Authorities.

On-road caravans are not permitted on any un-sealed road, being a road or track not sealed with a hard material such as tar, bitumen or concrete with exception of roadways within designated caravan parks. Night time driving is not recommended due to the high possibility of animal strikes.

Any breach of the specific driving conditions by the hirer can result in full forfeiture of the security bond applicable. A hirer's liability is unlimited in relation to Property Damage, Consequential Loss or Third Party Damage.

VEHICLE SUPPLY

Vehicles are booked for hire by reference to type not brand or model.

The company can disclose that due to the production cycle for the 200 series Landcruiser ceasing in 2019 the company will be replacing this model with other suitable Toyota 4WD models in the same specification as our 200 series fleet.

The company will use its best endeavours to supply the vehicle as nominated at the time of booking. Our primary aim is always to deliver the equipment as booked or, at the least, suitable equipment that allows their experience to take place. (Fit for purpose)

The Company reserves the right in its absolute discretion to substitute or replace any Vehicle booked with another Vehicle of the same or similar type if the booked Vehicle is unavailable due to unforeseen circumstances.

If a Vehicle of the same or similar type is not made available to the Hirer as a substitute or replacement Vehicle, the Hirer may terminate the Hire Agreement by giving notice in writing to the Company to that effect.

In such circumstances, the Hirer is only entitled to, and the Company's obligations are limited to, a refund of any hire charges paid by the Hirer in respect of the Vehicle at the rate or rates specified in the Contract or, if the Hire Period has already commenced, a pro rata portion thereof.

ELECTRONIC GPS TRACKING

The Customer agrees that vehicles are fitted with global positioning system vehicle tracking and diagnostics (telematics). Customer's personal information, including but not limited to, current and previous locations, usage, speed and distances travelled are recorded and used in accordance with the Company's Privacy Policy.

PERSONAL LOCATOR BEACON (PLB)

PLB are offered as a safety feature at no additional charge. PLB's are provided for emergency use. Call or Activation Costs are the sole responsibility of the hirer and will be charged to the Credit Card offered as security over the hire.



ROADSIDE ASSISTANCE

In the unlikely event that, Roadside Assistance is required; the hirer can contact the number on the front windscreen/ glovebox/ key ring of the vehicle, 24 hours per day for assistance.

ADDITIONAL DRIVERS

Additional drivers are permitted at no extra charge, although they must be recorded on the booking agreement at the time of hire and present a valid unrestricted driver's licence.

ANIMALS

No animals are permitted in our vehicles, campers or caravans, except guide dogs.

SMOKING AND VAPING

Smoking and vaping are strictly prohibited within and around our vehicles, campers, or caravans. Should traces of smoke or vapor be detected, a cleaning fee will be imposed.

TRAVEL INSURANCE

Crikey Campers does not offer any form of travel insurance or elation waivers for insurable events. Therefore, the company strongly recommend hirer/s take out travel insurance from the date of booking.

SECURITY BONDS

All Hirers are subject to payment of a Security Bond, This is processed against a valid Credit Card prior to the commencement of the hire period. The Credit Card must be in the name of at least one person listed in the rental agreement.

Refunds of security bonds will be processed within 21 days after the conclusion of the hire. In the event that a Security Bond claim is pending then any balance of the Security Bond will be processed within 14 days of the conclusion of the claim process.

The Claims process concludes once the company has reasonably determined the Hirer's total liability to the Company. The Hirer agrees that it is the company's discretion if this determination is reached via Invoice, quote or reasonable estimate.

If Crikey Camper resolves the Security Bond claim through a Quote or Estimate, and once the total liability is established:

- a. Should the quote or estimate surpass the assessment, the hirer will receive a refund for the amount exceeding the quote or estimate within 21 days.
- b. Should the quote or estimate be lower than the assessment, the hirer remains liable for the difference and agrees to pay Crikey Camper within 21 days upon receiving a Company invoice.
